

## **General terms and conditions of the Reproduction Agreement of the Museum of Fine Arts, Budapest (“MFAB”)**

The Museum of Fine Art as the preserver of fine arts objects (paintings, sculptures, prints and drawings and medals) and archeological findings, takes digital image reproductions of its objects for scholarly and publication purposes. The digital images can be purchased for a user fee according to the planned period of usage. The user fee is based on the given data in the submitted request form.

1. Museum of Fine Arts, Budapest confirms receipt of purchase order within 15 days. User may only use images to the extent and in the purpose permitted in PO confirmation, issued by Museum of Fine Arts, Budapest.
2. User shall transfers user fee to bank account number featured in Museum of Fine Arts, Budapest’s PO receipt:

3. All costs of bank transfer shall be paid by User. Relevant reference number must be indicated in the course of bank transfer.
4. Granting of permission for usage is subjected to payment of the user fee. In the event that User fails to settle the user fee, permission shall be rejected.
5. In the event that images are not used for any reason within the permitted period, User is not entitled to reimbursement of the user fee.
6. Within 15 days of receipt of user fee the MFAB – simultaneously to sending the digital version of the image – sends to the User the invoice of the user fee.

7. User can access digital image via an FTP server.
8. In the event of any usage contrary to conditions specified in PO receipt, User is obliged to pay Museum of Fine Arts, Budapest three times the original user fee.
9. Upon usage user is obliged to feature the following credit:

Artist, title of work

Szépművészeti Múzeum/ Museum of Fine Arts, Budapest, year of usage, name of photographer

10. User is obliged to send a free copy of the publication or object within three weeks from its release to the following address :

11. Unless otherwise agreed in writing, permission for use is subject to a user fee, is non-exclusive and valid only for one occasion within a period of one year from the signature of the agreement. Any further or additional usage must be agreed separately by the Parties.
12. The MFAB reserves ownership rights and reproduction rights on all digital images (hereinafter: "reproduction") made by the MFAB or any person assigned by the MFAB.
13. The copyright on the reproduction made by the MFAB or any person assigned by the MFAB is irrespective of the eventual rights to the depicted original work of art. Regarding such rights User must obtain permission separately from the party authorized to grant such rights. In such cases, the User must himself determine whether and the extent to which such permission may be necessary, and the MFAB undertakes no liability for any possible claims by third parties.

14. Use of reproduction image with different conditions to those authorized, or without prior permission of the MFAB, is strictly forbidden.
15. It is also strictly forbidden to transfer in any way or for any purpose the reproduction or the copy thereof to third parties without prior permission of the MFAB.
16. It is strictly forbidden to distort, mutilate (e.g. cut or crop) or alter (e.g. superimpose with a text) the reproduction in any way without prior permission of the MFAB. If – with the permission of the MFAB – only part of the image is reproduced, the credit line must include the indication “detail”.
17. Digital images and text shall be deleted from all carriers after their usage.
18. The Parties shall settle all disputes or controversies arising from or related to the concluded agreement (the purchased order and its confirmation) in amicable way.
19. Questions not regulated by the present general terms and conditions shall be governed by the laws and regulations of Hungary, the Hungarian Civil Code (Act No. V of 2013) and the Hungarian Copyright Act (Act no 1999. LXXVI.) shall apply.
